PROJECT DESCRIPTION/LOCATION: The existing bridge housing facility at 100 E. Sunset Avenue is operating under a Coastal Development Permit (CDP) de minimis waiver from the Coastal Commission at least through October 29, 2023. CDP Application No. 23-04, under review by the City Engineer, proposes that the facility would continue operating and cease operations no later than December 31, 2024, and site improvements would be removed within a reasonable timeframe after the cease of operations.
